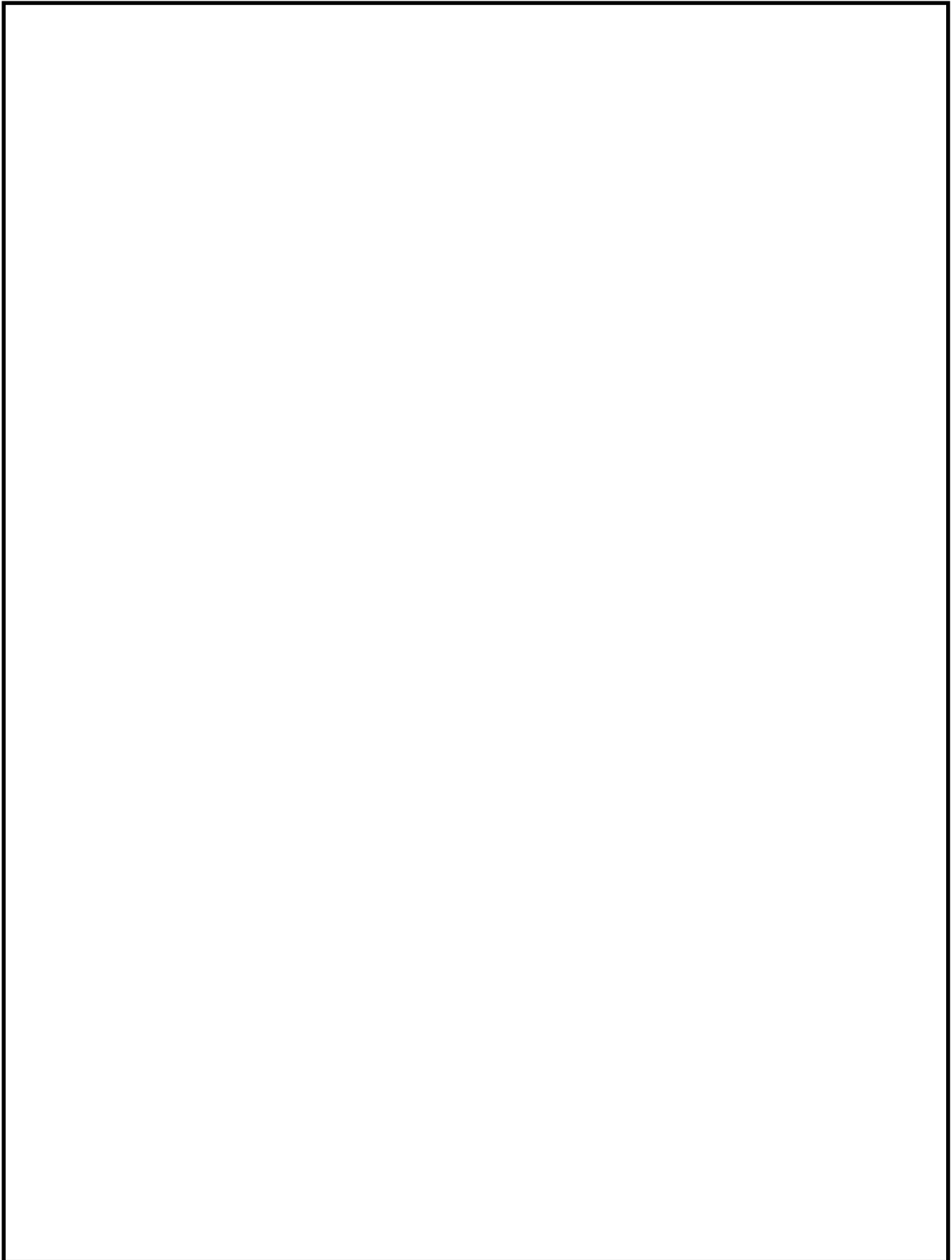
Youth Strategy (4Uth)
